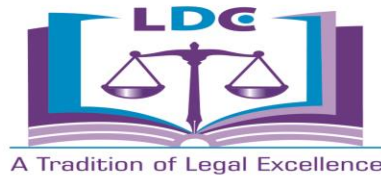


BID NOTICE UNDER OPEN DOMESTIC BIDDING

1. Law Development Centre has allocated funds to be used for the acquisition of [Modification of the Printery Building].
2. The Entity invites sealed bids from eligible bidders for the provision of the above works.
3. Bidding shall be conducted in accordance with the procedures contained in the Public Procurement and Disposal of Public Assets Act, 2003 (the Act) and the Regulations made under the Act and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding document at the address given below at 8(a) from [8:00Am -5:00Pm].
5. The bidding document which has been prepared in the *English language* may be purchased by interested bidders at 8(b) upon payment of a non-refundable fee of *UGX 200,000*. The method of payment will be [Bank deposit].
6. Bids must be delivered to the address below at 8(c) at or before [11:00Am and 13th-May-2022]. All bids must be accompanied by a bid security of (*UGX 30,000,000*). Bid securities must be valid until (*28th-January-2023*). Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at [11:30Am and 13th-May-2022]
7. There shall be a site visit at [Law Development Centre, Kampala Campus and 12:00Pm] on the dates indicated in the proposed schedule in this notice.
