2. The Entity invites sealed bids from eligible bidders for the provision of the above works.
3. Bidding will be conducted in accordance with the open *domestic* bidding method contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and is open to all bidders.

5. The Bidding documents in *English* may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of UGX 200,000]. The method of payment will be [Cash to cashier LDC].
6. Bids must be delivered to the address below at 8(c) at or before [11:00Am and 30th-November-2018]. All bids must be accompanied by a bid security of (UGX 90,000,000). Bid securities must be valid until (28th- July-2019]. Late bids shall be rejected.
