

Important Notes to all Participants

- Students who have passed the course will graduate on a date to be announced.
- Graduation fee: Candidates who have passed the course should pay 340,000/=.
This fee is divided as follows: Transcript and certificate (shs.200,000/=), Graduation ceremony (shs.100,000), certification of two copies (40,000). The money should be deposited on URA Account. Please login on to the student's portal (student ldc.ac.ug) and follow instructions. Only students who will have paid graduation fee will receive their academic documents on the day of graduation.
- The special and supplementary examinations will be conducted towards the end of next intake (November or December, 2021). You will be

required to pay Shs. **100,000=** per subject for the special/supplementary examinations.
