### **Call for Applications to join the Bar Course, 2022/2023 academic year**

The academic Registrar Law Development Centre invites applications for admission to the Bar Course, 2022/2023 academic year. The Bar Course shall be conducted at our three campuses in Kampala, Lira and Mbarara through physical learning or a blend of physical and virtual learning. LDC shall have only one intake for the academic year 2022/2023.

#### **Eligibility**

To be eligible for admission to the Bar Course, the applicant should be:

- a) A holder of a degree in law granted by a University in Uganda whose law programme has been accredited by the law Council.
  - i. This applies to Ugandan and Non-Ugandan citizens
  - ii. The degree must have been obtained from a university or institution of higher education duly licensed or chartered under the laws of Uganda and accredited by the Law Council. The license or charter should have been obtained prior to your enrolment on the LLB programme.
- b) A citizen of Uganda who is a holder of a degree in law obtained from a University or institution in a foreign country operating the common law system and recognized by the Law Council of Uganda. Applicants with foreign qualifications must obtain from the Law Council prior clearance in writing. Applications with foreign qualification without clearance from Law Council shall not be processed.
- c) A former Bar Course student intending to repeat the entire Bar Course or subject(s) as provided for by the applicable Rules for passing the Bar Course.

## How to apply

Interested applications should submit their applications online via the link: <https://admissions ldc.ac.ug>. The application fee is 200,000/- payable to the URA account. Please visit [www ldc.ac.ug](http://www ldc.ac.ug) and click on 'apply now' to complete the application process. You will be prompted to generate a Payment Reference Number (PRN). The PRN is required to make a payment in the bank. **Do not pay using mobile money as such payment may delay to reflect in the system.** For any enquiry about payments, send an email to [finance@ ldc.ac.ug](mailto:finance@ ldc.ac.ug).

Please note that only application forms submitted online with evidence of payment shall be received and processed.

Applicants will have the option to indicate their preferred campus. However, an applicant admitted to the Bar Course may be posted to any LDC campus at the discretion of the Centre.


## Note

1. Applicants who were admitted during the Academic Year 2021/2022 (intake 2) and received offer letters need not reapply. They will receive admission letters before commencement of the course.
2. An applicant admitted to the Bar Course may be posted to any LDC campus.
3. Current undergraduate students who have not yet completed their LLB degree programme are ineligible to apply for admission. The respective accredited law schools must provide lists of eligible students before close of the application deadline.

Application should be submitted not later than **Friday 26 August, 2022**
